MARRIAGE LICENSE

Marriage license applications are processed Monday through Friday between the hours of **8:00 a.m.** and **4:00 p.m.** Requirements are as follows:

- Both the Applicants must be over the age of 18.
- **Both parties must be present.**
- ID (Driver's License preferred) of both parties is required.
- If either party was previously married, you must provide a **Final Decree** of divorce or, if a previous spouse is deceased, a copy of their **Death Certificate.**
- Marriage licenses are issued at the time of application and there is no waiting period before the ceremony can occur. **Jackson County Probate Court does not perform wedding ceremonies.**
- Marriage licenses are good for up to six (6) months after issuance.

The cost of the license is **\$56.00** if paying by cash or check, or **\$58.24** if paying with debit/credit cards (Visa/MasterCard accepted).

However, if you have completed at least 6 hours of pre-marital counseling, then the cost of the license will be reduced to **\$16.00** if proof of such counseling is provided. In order to qualify for the reduced fee, the couple must provide a Certification of Completion of Qualifying Premarital Education form (available from Probate Court) with the notarized signature of the person who conducted the counseling. Alternatively, you can provide a letter from the counselor, on their letterhead, or a certificate from the counselor verifying that at least six (6) hours of counseling has been completed.
